## ANNUAL CONTRIBUTION TO THE SUPERINTENDENCY OF COMPANIES, SECURITIES AND INSURANCE

Dear Clients and Friends:

In Official Register No. 249 of March 23, 2026, Resolution No. SCVS-INAF-2026-00002608 was published, pursuant to which the Superintendency of Companies, Securities and Insurance (*Superintendencia de Compañías, Valores y Seguros - SCVS*) sets the fee for the contribution payable to it by domestic companies, branches of foreign companies, and other entities subject to the control and supervision of the SCVS.

In the aforementioned Resolution, the contribution payable by companies and other entities subject to the control and supervision of the SCVS whose net assets exceed US\$100,000.00 is set at **1 per mille (0.001)** of their net assets.

For entities whose assets have a value between USD 0.01 and USD 100,000.00, the SCVS sets the contribution for fiscal year 2026 at US\$0.00.

The 2026 contribution shall apply, in accordance with the following detail, to companies that file their financial statements within the statutory deadlines or within such deadlines as may be established by the Superintendent of the SCVS:

By September 30, 2026, domestic companies, branches of foreign companies, and other entities supervised by the SCVS must pay the aforementioned annual contribution. Companies that pay at least 50% of the contribution by that date can request an extension to pay the remaining balance until December 31, 2026, without penalties or surcharges.
